Appreciated Assets

Donating appreciated assets can offer significant tax advantages. Donations of appreciated, publicly traded securities are one of the most tax-wise methods. The most common forms of these assets are shares of stock, bonds and mutual funds.

If you donate assets that have increased in value since you bought it more than a year ago – and if you itemize deductions – you can take a charitable deduction for the stock's fair market value on the day you give it away. You will also avoid capital-gains taxes on the increase in value over time, which you would have had to pay if you sold the stock then gave the charity the cash proceeds. If you have held it for less than a year, your deduction is limited to your cost basis -- what you paid for the stock --not the current value.
